2012 "SAMOSA" FESTITVAL

We organised a chess tournament which was held at Karura Forest on 23rd September 2013 during the on-going "SAMOSA" (South Asian Mosaic of Society & the Arts) Festival.

Nairobi Chess Club v Team Uganda



The Uganda team was led by the following four players; FM Harold Wanyama, FM Elijah Emojong, CM Bob Bibasa & Haruna Nsubuga.

55th Nairobi Chess Club Championship

The 55th Nairobi Chess Club Championship held over the weekend of 24th & 25th August 2013 at the Braeburn Schoo lwas a resounding success. The event was attended by 64 players which included 3 Ugandans. The total cash prize fund of KSHs 67,500 was one of the largest in recent years.

Venue

The club has now for the past 4 ½ years been meeting at the Goan Gymkhana Club which is one of the best venues in terms of ambiance and easy and safe parking for members. The club currently meets every Saturday and has also launched a junior program to spread the game amongst the youth.

Chess Kenya

The club actively supports Chess Kenya by participating in the National League and came out 5th in the 2010/11 edition. We have registered for the 2013 National League and currently lead the table with a maximum of 8 points in an event which is scheduled to end in December 2013.

Administration

The club executives have committed to ensuring that the club is properly organised in terms of its financial affairs and is the only chess club to present a proper set of accounts. The accounts are maintained on the QUICKBOOKS system and quarterly accounts are presented to members and sponsors.

A separate section in the financial statements discloses all the transactions with the club officials.

The website was launched on 13th January 2011 and has received almost 4,000 hits so far.

A Facebook group page has been in existence for over two years and continues to attract new members and now has over 900 Likes.

It is always difficult to single out thanks in a report like this. Nairobi Chess Club has hundreds of supporters in Kenya and abroad who support us in our endeavours. I wish to specifically thank my committee members, sponsors and all the players who grace our events.
